

#### **Opening Transendance**

TranscenDANCE was founded in 2005 with the mission of being a youth-driven organization where young people have a platform to positively impact the world around them through performance.

The need for the organization arose out of several youth-identified needs in the community. These needs included youth delinquency prevention, access to youth-tailored creative spaces, access to fitness and health classes, and youth leadership development. In addition, the youth in the local area expressed the desire to build a supportive and diverse community that would address a growing sense of isolation among its youth by providing creative outlets for personal expression.

#### Welcome: Summer Stephan

District Attorney Summer Stephan has devoted her life to protecting children and families and providing justice to the voiceless and most vulnerable. She is a national leader in the fight against sexual exploitation and human trafficking, who has served as a Deputy District Attorney in San Diego County for 27 years.
