- Homelessness:
  - Cathy Hilton - Business Chamber is setting up a committee on homelessness
  - Educate the kids
  - 23,000 homeless children in SD County
  - Rachel Cano & Sherry Ludwig passed out the FAQ from the Monarch school
    - At capacity at 300
    - Service people from the entire County
    - Public school system (50% funds from County, 50% funds from private funding)
    - Sherry Ludwig & Rachel Cano invited the CEO to present at one of the Commission's upcoming meetings & Symposium
    - Monarch School has a "boutique" for donations
  - Leah Goodwin – attended RISE Urban Breakfast Club event:
    - "Feed the Meter"
    - Need to scatter the services around the County
    - Socks & bottled water are a top requested donation
  - 11/19 – Lions Club is feeding the homeless, 12:00 – 5:00, let Maria McEneany know if you would like to volunteer (12 open spots to fill)
